REGULAR MEETING

Mayor Morrison opened the regular meeting at 6:31 p.m.

1. ROLL CALL

7. PUBLIC HEARINGS

7.1 WAIVE FIRST READING AND INTRODUCE ORDINANCE 1037 AMENDING THE LARKSPUR MUNICIPAL CODE BY ADDING CHAPTER 5.38 ESTABLISHING A TOBACCO RETAILER LICENSE PROGRAM AND REGULATING THE SALE OF TOBACCO PRODUCTS, REPEALING CHAPTER 6.16.130, AND AMENDING CHAPTER 6.16.010

City Clerk Jamie Kuryllo reported on the proposed Ordinance, which would establish a Tobacco Retailer License and regulate the sale of tobacco products.

Mayor Morrison opened the public hearing. Council received public comment. Mayor Morrison closed the public hearing.

Upon motion by Councilmember Hillmer, seconded by Councilmember Way, Council waived the first reading and introduced Ordinance 1037, as amended below, by acclamation.

SECTION 3: Section 6.16.130 is hereby repealed.
